

# NOTICE OF 2018 TAX YEAR PROPOSED PROPERTY TAX RATE FOR THE CITY OF HUMBLE, TEXAS

A tax rate of \$0.248572 per \$100 valuation has been proposed by the governing body of the City of Humble, Texas. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of the City of Humble proposes to use revenue attributable to the tax rate increase for the purpose of offsetting expenditures from disaster recovery, additional positions, including public safety, related training and equipment; professional services; infrastructure maintenance and improvements; and facility improvements.

PROPOSED TAX RATE	\$ 0.248572 per \$100
PRECEDING YEAR'S TAX RATE	\$ 0.225471 per \$100
EFFECTIVE TAX RATE	\$ 0.230160 per \$100
ROLLBACK TAX RATE	\$ 0.248572 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for the City of Humble from the same properties in both the 2017 tax year and the 2018 tax year.

The rollback tax rate is the highest tax rate that the City of Humble may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

Property tax amount = (rate) x (taxable value of your property) / 100
