Survey of Property (legal description- lot, block, section) – New Construction

TSAR Elevation Certificate

If property consists of two or more lots, a current survey must be provided and attached to plan review indicating property to be one lot

Tax Payment Verification

Check with the Harris County website prior to permits being issued confirming that all existing City of Humble and Humble ISD property taxes have been paid

Sewer Capacity

A separate fee payable to the water department is required for sewer capacity, this fee is collected prior to building permits being issued.

Performing Work without Fore Sprinkler, Fire Alarm, Commercial Suppression Permit Penalty:

Violation of Sections 105.1 and 109 IFC, May be cited as a Misdemeanor punishable by up to \$2,000.00 for life safety violations or \$500.00 for all other violations as prescribed in §1.11 of code of Ordinances. Each day shall constitute a

separate offense.

Failure to Obtain Certificate of Occupancy:

Violation of Sections 111.1 and 114 IBC, Misdemeanor punishable by up to \$2,000.00 for life safety violations or \$500.00 for all other violations as prescribed in §1.11 of Code of Ordinances. Each day shall constitute a separate offense.

Performing Work without A Permit Not Governed by the IBC or IFC:

Double Permit Fee.

- 1) Builder/Contractor must provide the municipality with a letter on company letterhead identifying the third party inspector as well as company name.
- 2) The Energy Code Inspector must provide the municipality with the following:
 - a. A copy of Valid Driver's License
 - b. Business Card with company name, contact name, address and telephone number.
 - c. 2012 Energy Certification
- 3) Prior to certificate of occupancy, the following documents are required:
 - a. A certificate of elevation
 - b. 2012 Energy Code compliance letter
