5. <u>CHANGE ORDER NO. 1 EAST TOWNSEN BLVD./NORTH HOUSTON PAVING,</u> DRAINAGE AND UTILITY IMPROVEMENT PROJECT

City Manager Darrell Boeske presented Change Order No. 1 for the East Townsen Boulevard/North Houston Paving, Drainage and Utility Improvement Project in the amount of \$ 56,382.80. He stated the change order would include:

- (1) Meek Road Drainage \$32,004.00 for the extension of a 30" concrete drainage pipe 530' west of East Townsen to help eliminate flooding
- (2) North Houston Sewer Extension \$ 17,569.00 for the extension of a 12" sanitary sewer line 171' north under First Street to provide sewer service to the Artesian Well/Lambert Town area
- (3) North Houston Avenue Drainage Ditch \$ 13,084.50 to pave the area that falls between the new concrete lined ditch and the Hirsch Park fence to reduce maintenance by eliminating mowing and weeding this ditch.
- (4) East Townsen Asphalt Shoulder (\$6,275.00) decrease due to a change in the installation procedures for the sub-base for the should on East Townsen.

Councilman Allan Steagall moved that Change Order #1 be approved in the amount of \$ 56,382.80.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS AUTHORIZING THE MAYOR TO CONVEY OWNERSHIP OF TWO BUSES TO HARRIS COUNTY FIRE AND EMERGENCY SERVICES TRAINING ACADEMY

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

<u>Section 1</u>. That the Mayor be, and he is hereby, authorized to convey ownership of two buses:

1986 International VIN# 1HVLNHGN9GHA52346 and 1986 International VIN# 1HVLNHGN2GHA52348

to the Harris County Fire and Emergency Services Training Academy.

<u>Section 2</u>. That no warranty on specified buses is either intended or implied. The bases are donated AS IS - WHERE IS AND WITH ALL FAULTS AND DEFECTS THEREIN and the City of Humble is therefore removed from all liability of said buses.

8. <u>MICHAEL COTHRAN, PRESIDENT, COALITION OF HOMEOWNER ALLIANCES</u> REQUIRING GOVERNMENT EQUITY (CHARGE)

Michael Cothran, President of the Coalition of Homeowner Alliances Requiring Government Equity (CHARGE), appeared before the mayor and councilmembers to discuss community issues of interest regarding the Bush International Airport expansion. His main points were:

CHARGE's problems with the airport expansion:

- 1. no City of Houston constituents around or affected by airport operations
- 2. noise pollution
- 3. air pollution
- 4. property devaluation
- 5. potential for disaster
- 6. political entities not speaking up for people they represent
- 7. for the City of Humble more runways and increased airport operations

CHARGE's cures for airport expansion issues:

- 1. noise abatement program
- 2. land use management to keep the air lanes clear of noise sensitive development
- 3. FFA reconfiguration of IAH airspace

CHARGE would like City of Humble do:

1. since Humble is most affected city, would like to have a representative on

CHARGE

- 2. develop city's stance on the issue
- 3. ask for the development of a user fee for noise abatement.

Mayor McMannes informed Mr. Cothran that the City has tried to convey some of the City's concerns to the City of Houston. He stated the City Manager, Mr. Boeske, would be available to meet with the representatives of CHARGE when necessary.
