Presentation, possible action, and discussion on an ordinance amending Chapter 12, "Buildings and Building Regulations", Article XI "Development Standards", by deleting the entirety of Section 500 "Exterior Construction Requirements for Non-Residential and Multifamily Residential Buildings" and Section 600 "Exterior Construction Requirements For Auxiliary Buildings Located On Single Family Residential Property"; replacing both with a new Section 500 "Exterior Construction Requirements For All New Buildings"; making certain findings; imposing a penalty in the amount of \$500.00 as set out in Section 1.11 of the Code of Ordinances for each day of violation and providing for severability.
- 4. Public Hearing, presentation, possible action, and discussion on an ordinance amending Chapter 12, "Buildings and Building Regulations", Article VI "Flood Damage Prevention", and Chapter 38, "Subdivisions", of the Code of Ordinances to increase the elevation for new construction and substantial improvements of residential and non-

residential structures to two feet above the 500-year flood elevation; making other findings and provisions related thereto; providing a penalty up to \$2,000 per day for each violation; providing for publication and an effective date.
