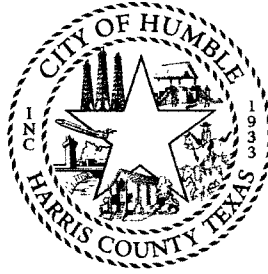


**7. Adjournment.**
