11. ORDINANCE NO. 12-704 ESTABLISHING A FIRE LANE NO PARKING ZONE AT THE NORTHERN END OF SAMMON STREET AND NINETY (90) FEET OF THE WESTERN SIDE FROM THE INTERSECTION WITH ISAACKS ROAD

City Manager Boeske presented a request from Fire Marshal Clint Johnson to approve an ordinance establishing a Fire Lane No Parking Zone on Sammon Street and recommended approval.

ORDINANCE NO. 12-704

AN ORDINANCE OF THE CITY OF HUMBLE ESTABLISHING A FIRE LANE NO PARKING ZONE AT THE NORTHERN END OF SAMMON STREET AND NINETY (90) FEET OF THE WESTERN SIDE FROM THE INTERSECTION WITH ISAACKS ROAD

WHEREAS, the City of Humble Fire Marshal has declared the necessity of a Fire Lane with No Parking zone to facilitate the unobstructed access of fire fighting apparatus onto and from Sammon Street; and

WHEREAS, this Fire Zone will enhance the services of the City of Humble Fire Department to respond to emergency calls from the subdivision; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

Section 1. A Fire Lane No Parking zone has been established at the northern end of Sammon Street and ninety (90) feet south of the western side from the intersection with Isaacks Road as shown on Exhibit "A"; and

Section 2. Any person violating the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in any sum not more that Two Hundred Dollars (\$ 200.00).

Section 3. This ordinance shall be in effect ten (10) days after passage.
