

BASED ON PRELIMINARY TAX INFORMATION **PROPOSED OPERATING BUDGET** **FOR FISCAL YEAR 2013-2014** **In accordance with SB 656**

This proposed budget is estimated to raise less revenue from property taxes than last year's budget by an amount of \$100,000, which is a 4.0% decrease from last year's budget. Based on taxable value information currently available from the Harris County Appraisal District, it is not possible at this time to determine the amount of this additional property tax revenue to be raised from new property added to the roll this year.
